ENROLMENT



ADMISSION & WELCOME UNIT GLOBAL ENGAGEMENT OFFICE

- The Admissions & Welcome Unit is temporary located in via Venezia 13 from 23rd August to 29th October
- For the enrolment finalisation:
 - If you obtained your qualification in a non-EU country, you need to book an in-person appointment <u>here</u> (select the option "Welcome desk for degree seekers") and hand in your original documents;
 - If you obtained your qualification in a **EU country** AND/OR if you hold a **Diploma Supplement** in the <u>standard format approved within the framework of</u> <u>Bologna Process</u>, you are exempted from booking an appointment in person.





BACHELOR'S DEGREE APPLICANTS

1) Upper secondary school certificate (achieved after at least 12 years of schooling) translated (Italian/English) and legalised.

N.B: If in the country where you achieved your qualification, an entrance exam is set for the admission to University, you must provide a certificate showing you have passed that test.

2) One of the following documents:

a) **Statement of Comparability** (Attestato di Comparabilità), issued by CIMEA. Students can request such certification (upon payment) through a personal account on <u>MyDiplome</u>. Enrolled students at UniPD will be reimbursed through the second instalment of university tuition fees, unless they benefit from full tuition fee-waivers or scholarships of any kind.

b) **Declaration of Value** (Dichiarazione di Valore), issued by the Italian Embassy or Consulate in the country where you have obtained your diploma.



1.2.2 REQUIRED DOCUMENTS

MASTER'S DEGREE APPLICANTS (1)

1) **Bachelor's diploma** (or alternatively post-secondary qualification which allowed you the admission) **translated** in Italian or in English and **legalised**.

2) **Transcript of Records** released by the competent academic authority, stating passed exams. It must be **translated** (in Italian or in English) and **legalised**.

3) Proof of **English language proficiency** (if not provided yet)





MASTER'S DEGREE APPLICANTS (2)

4) One of the following documents:

a) **Statement of Comparability** (*Attestato di Comparabilità*), issued by CIMEA. Students can request such certification (upon payment) through a personal account on <u>MyDiplome</u>. Enrolled students at UniPD will be reimbursed through the second instalment of university tuition fees, unless they benefit from full tuition fee-waivers or scholarships of any kind.

b) **Declaration of Value** (*Dichiarazione di Valore*), issued by the Italian Embassy or Consulate of the country **where you have obtained your diploma.**

c) **Diploma Supplement** (only for qualifications obtained within the framework of Bologna Process) issued by the University where you have obtained your diploma along with the final degree.



TRANSLATION AND LEGALISATION OF DOCUMENTS

Academic Qualifications and certificates must be submitted with an **official translation** according to the <u>rules set by the Italian Ministry of Foreign Affairs and</u> <u>International Cooperation (MAECI)</u>.

Legalisation is required in order to guarantee the document authenticity and can be obtained at the Italian Embassy or Consulate of the country where the Diploma has been awarded.

If the country where the qualification has been awarded is a <u>member of the Hague</u> <u>Convention</u> (1961), an **Apostille** must be affixed by competent authorities, instead of legalization.

Should you have difficulties in obtaining Legalisation/Apostille, you can alternatively request the Statement of Verification (*Attestato di Verifica*) issued by CIMEA. Students can request such certification (upon payment of a \in 65 fee) through a personal account on <u>MyDiplome</u>.

TRAVELLING TO ITALY



- The Italian Government has identified 6 groups
 of countries, each with specific prescriptions in
 order to enter to Italy
- Entry status can be:
 - a. ALLOWED
 - b. ALLOWED with SPECIFIC REQUIREMENTS/LIMITATIONS
 - c. BANNED

Current prescriptions in accordance with the new Ordinance of 28th August, 2021 Valid until 25th October 2021





Please note that restrictions and regulations may be changed by the Italian Government according to further developments of each country's COVID-19 situation.

VACCINATION



3.1 AUTHORISED VACCINES

EMA (European Medicine Agency) authorised vaccines:

- <u>Comirnaty</u>(Pfizer)
- Spikevax (previously COVID-19 Vaccine Moderna)
- Vaxzevria (previously COVID-19 Vaccine AstraZeneca)
- COVID-19 Vaccine Janssen (Johnson & Johnson)



The following vaccines, while not authorised by the EMA, are considered equivalent to authorised vaccines:

- Covishield (Serum Institute of India), produced under license from AstraZeneca;
- R-CoVI (R-Pharm), produced under license from AstraZeneca;
- Covid-19 vaccine-recombinant (Fiocruz), produced under license from AstraZeneca;

Currently under rolling review (non-authorised yet)

- NVX-CoV2373 (Covovax)
- CVnCoV (CureVax)
- Sputnik V (Gam-COVID-Vac)
- COVID-19 Vaccine (Vero Cell) Inactivated
- Vidprevtyn (Sanofi-GSK)

More vaccines are currently being used and/or researched but have not been submitted for the EMA authorisation

3.2 VACCINATION IN ITALY

Can I get vaccinated in Italy?

Yes, you can.

After your arrival in Italy and after having completed the isolation period (if required by regulations),



you must send an email to <u>emergenzacovid19@aulss6.veneto.it</u> indicating:

NAME - SURNAME - DATE OF BIRTH - TAX CODE - PLACE OF BIRTH CITIZENSHIP - RESIDENCE - DOMICILE - MAIL - TELEPHONE NUMBER

If you miss any of these required information, please wait before sending the email. Please note that incomplete requests will not be processed.



Can I get the second dose in Italy?

Yes, if you have already received the first dose of one of the EMA-authorised vaccines.

After your arrival in Italy and after having completed the isolation period (if required by regulations),



you must send an email to <u>emergenzacovid19@aulss6.veneto.it</u> indicating (see previous slide):

NAME - SURNAME - DATE OF BIRTH - TAX CODE - PLACE OF BIRTH CITIZENSHIP - RESIDENCE - DOMICILE - MAIL - TELEPHONE NUMBER

and attach a copy of a valid vaccination certificate*, indicating:

NAME OF THE VACCINE - BATCH - EXPIRY - PLACE OF PERFORMANCE

*the certificate is valid if in Italian, English, French or Spanish and with the stamp of the issuing body

COVID-19 MEASURES



To ensure the safety of all the people entering the University premises, please remember that the compliance with the following measures is mandatory:

- Holding a **GREEN PASS**
- Wearing a surgical mask

4.2.1 GREEN PASS

The **Green Pass**

- ✓ is a type of EU digital COVID certificate
- ✓ facilitates free and safe movement in the EU
- ✓ is <u>free of charge</u> (SCAM ALERT!)
- \checkmark is a digital and printable certification
- contains a two-dimensional barcode (QR Code) and a qualified electronic seal
- in Italy, it is issued <u>only</u> through the national platform of the Ministry of Health.



The *Green Pass* attests <u>one</u> of the following conditions:

- being vaccinated with an <u>EMA-authorised</u> COVID-19 vaccine (in Italy, it is issued both after the first dose and after the second dose);
- negative result of a molecular or antigen swab test within the past 48 hours;
- recovery from COVID-19 in the past six months (certified by molecular or antigen swab test)



4.2.2 GREEN PASS

From the 1st of September 2021, the "Green Pass" is compulsory* to access the following:

- restaurants, cafés (limited to indoor services)
- shows, sporting events and competitions;
- museums, other institutes and places of culture and exhibitions;
- swimming pools, gyms, wellness centres, team sports (limited to indoor activities);
- festivals and fairs, conferences and congresses;
- spas, thermal centres and amusement parks;
- cultural, social and recreational centres <u>(limited to indoor activities)</u> and with the exception of educational centres for children and related catering activities);
- gaming rooms, betting rooms, bingo halls and casinos;
- public competitions

*Those who cannot receive a vaccine for medical reasons can be exempted upon submission of a valid certificate.



4.2.3 GREEN PASS

From the 6th August 2021,

the Green Pass is compulsory* to access the following services and activities:

<u>University facilities</u>

University officials may request students to show their "Green Pass" (or other Covid Certificate which counts as a "Green Pass") Upon entering classes and other facilities. Student who will not fully comply will be restricted from entering classes and other University facilities.

- Long distance travel within Italy via:
 - Airplane
 - Train: «Alta Velocità» (Frecciarossa, Frecciargento, ...), Intercity, Intercity notte
 - Bus (i.e. flixbus, busses connecting two or more regions)
 - Boat

Regional and local public transport does not require having the Green Pass

*Those who cannot receive a vaccine for medical reasons can be exempted upon submission of a valid certificate.





EMA-unauthorised vaccine No, you can't

If you have received one of these vaccines, you can receive an additional dose with a vaccine recognised by EMA!

Duration of the Green Pass:

- It starts from the 15th day after receiving the first dose and its valid until receiving the final dose;
- It is valid for 270 days starting from the 15th day after receiving the final dose of vaccine

If you are an EU citizen and already have a EU digital COVID certificate, you do not need to request the Green Pass! If you are USA, UK, Canada, Japan or Israel citizen and already have an official digital COVID certificate, you do not need to request the Green Pass!

Can I get the *Green Pass* before getting vaccinated?

Yes, you can

Negative result of a molecular or antigen swab test

Duration of the Green Pass: 48 hours from the test

Recovery from COVID-19 certified by medical certificate

Duration of the Green Pass: 180 days from the release of the certificate

If you are an EU citizen and already have a EU digital COVID certificate, you do not need to request the Green Pass! If you are USA, UK, Canada, Japan or Israel citizen and already have an official digital COVID certificate, you do not need to request the Green Pass!



Due to the COVID emergency, the University of Padua decided to provide special economic benefits to its students, offering:

- Internet free of charge The University of Padova provides you with a SIM card with 60GB data per month for the entire academic year 2021/2022
- Discount on Laptop If you are a Unipd student, you will be able to benefit from special rates for the purchase of notebooks and tablets thanks to agreements with affiliated retailers.

RESIDENCE PERMIT



5.1 RESIDENCE PERMIT

- 1. Go to the Post Office Sportello Amico and collect the yellow kit
- 2. Set an appointment with SAOS Desk and fill out the kit
- 3. Go to the Central Post Office (Corso Garibaldi 25, Padova), pay the fee and send the kit
- 4. Keep the receipt issued by the Post office! It is considered your temporary residence permit
- 5. On the day written on the receipt, go to the Police Headquarters (*Questura*) for the fingerprints, with:
 - 4 passport-size photographs;
 - the original copies of the documents you sent with the kit;
 - your passport;
 - the receipt of your permit application.

The receipt contains two personal code numbers (User Id and Password) which enable you to follow the state of your application on <u>www.portaleimmigrazione.it</u>.

If the application is successful, the **electronic residence permit** will be issued in at least a month from the date of your first appointment. In any case, the permit will be issued for the length of your health insurance and for no longer than one year. To extend your stay in Italy, you will need to start the renewal process in good time, i.e. three months before it expires.



5.2 RESIDENCE PERMIT

When the permit is ready, the *Questura* will send you a text message to tell you when you can collect it.

Costs

- a €16 marca da bollo (revenue stamp) on sale at tobacconists' (tabaccheria)
- €30 for the service
- €70.46 for the issue of a one-year electronic residence permit

HEALTHCARE



- Students coming from EU countries can benefit from medical assistance in Italy thanks to the European Health Insurance Card (EHIC, in Italian "TEAM") issued by the competent health institution in your country of residence.
- The EHIC gives you access to the National Health Service for "urgently needed medical treatments" during temporary stay.
- You can voluntarily register in the National Health Service. The voluntary registration entitles you to benefit the Italian healthcare services like Italian citizens do; it is **valid for one calendar year** (from 1st January to 31st December); the payment is not divisible and you cannot apply retroactively.

Non-European students must hold a valid medical insurance in order to apply for

their residence permit. The medical insurance can be obtained through :

- private insurance
- voluntary registration in the National Health Service
 - **EHIC** only for students residing in a EU country

7.1.2 PHONE CALLS

Mobile Providers

There are many mobile providers available, each of them offering several voice and data packages. You should compare prices and conditions carefully!

You can get:

• a prepaid SIM card (*ricaricabile*): it must be regularly recharged with credit vouchers (*ricariche*) that can be done at tobacconists, bars, ATMs or online;

• a mobile contract (abbonamento), a permanent contract at a fixed monthly rate

To get a prepaid SIM card or a contract, you will need:

- identity document/passport
- Italian address
- tax code (codice fiscale)





TUITION and ECONOMIC MEANS



8.1 TUITION FEES

THREE INSTALMENTS PER YEAR

- The **FIRST instalment** is **€188,00** for **first-year** students. The payment is due when enrolling to any degree programme.
- The SECOND and the THIRD instalments are calculated according to your income, merit and individual situation.
 The SECOND instalment must be paid by 15th February 2022.
 The THIRD instalment must be paid by 16th May 2022.

How can you pay?

Through **PagoPA**, a method which guarantees safe and reliable electronic payments towards Italian Public Administration. This payment method is available via Uniweb (*Contribuzione*).

What is ISEE?

ISEE is an official certificate which indicates your financial standing in any given year on the basis of family status, earnings, property and expenses. You will need to provide information and documentation regarding you and your family's annual income and assets.

What is it used for?

It is required to access a wide range of economic benefits (tuition fees reductions, Regional Scholarship, ESU Accommodation etc.)

Where can I obtain the ISEE?

The ISEE is issued by the <u>CAF (*Fiscal Assistance Centre*)</u> CIA PADOVA VIA LONGHIN, 25 – 35129 PADOVA. Please read carefully the ISEE GUIDE downloadable at <u>www.unipd.it/en/isee</u>



8.3 VENETO REGION SCHOLARSHIP



INCOME-BASED SCHOLARSHIP OPPORTUNITY

WHEN TO APPLY: By September 30th

HOW TO APPLY: online, by filling in a specific form + ISEE at the CAF office

DURATION: 1 academic year, upon certain conditions (academic achievements, number of ECTS etc.). Renewable.



8.4 FLASH CARD

What is it?

The Flash Card proves your student status at the University of Padova and allows you to use certain services, such as access to university areas, library loans, electronic recognition before examinations etc.



How do I receive it?

After completing the enrolment procedure, it will be sent to your address. International students who have not indicated an Italian address on Uniweb <u>will</u> <u>receive an email</u> confirming that their Flash Card is ready to be collected at the Student Office. This email will be sent usually <u>about 4 weeks after your enrolment</u> <u>finalisation</u>.

Flash Up Studio

The Flash Card can also be upgraded to **Flash Up Studio** at one of the branches of Intesa SanPaolo bank, so that you can make bank transfers/payments, receive credits (scholarships, reimbursements, mobility grants, tutoring grants, etc.).




9.1 EDUCATIONAL OFFER

9.2 UNIVERSITY CREDITS

CFU – ECTS

Italian universities use the European Credit Transfer and Accumulation System (ECTS).

1 ECTS = 1 CFU (*"credito formativo universitario"*) = 25 coursework and workload hours.

- •1 academic year= 60 CFU/ECTS
- •Bachelor's degree programmes = at least 180 CFU/ECTS
- •Single-cycle degree programmes = at least 300-360 CFU/ECTS
- •Master's degree programmes = at least 120 CFU/ECTS



9.3 STUDY PLAN

STUDY PLAN

Your **Study Plan** is the detailed overview of activities to be completed in order to achieve your degree.

You must fill out your Study Plan in Uniweb after the enrolment. Before doing so, it might be useful to consult with the Tutor of your Department/School.

Exams can be:

- mandatory they will be automatically selected by the system.
- elective/surplus credits elective exams must be chosen among the exams included in the curriculum of your degree programme; surplus credits are optional exams which allow you to acquire extra credits (in addition to the total amount of credits required to obtain your degree qualification).



9.4 TEACHING MODE and LESSON TIMETABLES

During the first semester, the University of Padua will deliver classes **simultaneously in-presence and online**. More information will soon be made available by each Department.

Students facing major limitations in travelling to Italy will have the opportunity to start the academic year online and then come to Padua as soon as this is possible.

<u>NON-EU student residing outside Italy must apply for the Study VISA by 30th</u> <u>November 2021 nonetheless.</u>

PSYCHOLOGICAL ASSISTANCE

11.1 GETTING AROUND

City buses and tram are run by *APS Mobilità*: tickets can be bought at *edicole* (newsagents) and *tabaccherie* (tobacconists); bus passes are available at APS offices and online. A special transport for people with disabilities can be booked by phone: 840.00055

An on-call **night time bus** service, founded in collaboration between the University, the Municipality of Padova and Busitalia Veneto, is also available, upon request via the Night Bus App.
